



"The Treasure Called Tubbs Hill" Book Signing



To say that Scott Reed's book, "The Treasure Called Tubbs Hill" reception by the community has been phenomenal would obviously be an understatement. When Hastings sold their entire box of 52 copies in the first month, their district manager was amazed at the response to a local history. With appearances at Coeur d'Alene Parks Day Celebration, The Saturday Farmer's Market, Art on the Green and a number of signing events following the book's June release, Scott has continued to give his support to this on-going labor of love. The

1,000 first printing has now sold out, but a second printing has arrived in time for Christmas sales. Reflecting on the success of Treasure Scott quipped: "I outsold my son in Kootenai County." [In fairness, one must note that Bruce's The Plan, cowritten with Rahm Emanuel, is currently enjoying a resurgent popularity with Emanuel's appointment as Chief-of-Staff for President-elect Obama.]

Though the appeal of <u>Treasure</u> is as uniquely local as the park it celebrates, orders have been shipped to Florida, Utah, Pennsylvania and several Mid-west states. That interest by former Coeur

d'Alene residents and their extended families serves well as a reminder of the importance of preserving the lakeside sentinel that long-time community members too often take for granted. As Mayor Sandi Bloem says in her foreword, "Being able to study the sometimes perilous history of how Tubbs Hill came to be preserved makes it that much more precious....[the book shows] how individual citizens can make a difference and preserve what is best about our special place for generations to come."

Now, Friends Of Tubbs Hill are invited to a public signing of this definitive history of Coeur d'Alene's most unique recreational setting. Scott Reed will sign books at the Coeur d'Alene Hastings on December 14th from 1-3 p.m. All proceeds from the book's sales, as you no doubt have heard, have been dedicated to the Tubbs Hill Foundation's ongoing efforts to preserve the park. The book may also be purchased through Borders, The Coeur d'Alene Resort or the Coeur d'Alene Parks Office in City Hall.

If you would like to engrave your company's logo on a separate corporate monument, the cost is \$500, plus the engraving charge. The maximum logo size is 4" x 4".


