### **Spring 2016 Cleanup**

# SAVE THE DATE! Tribute to Art Manley & Scott Reed

On July 1st, the Tubbs Hill Foundation and the Kootenai Environmental Alliance will co-host a community tribute to commemorate the work done by Art Manley and Scott Reed to keep Tubbs Hill in public ownership and make it available for all in our area to enjoy. New memorial stones, with plaques honoring the two men, will be unveiled at the event, which will be part of Art M a n l e y - S c o t t R e e d Day as proclaimed by Mayor Widmyer.

The event, which begins at 5 p.m., will feature live music, free huckleberry ice cream and huckleberry lemonade, short speeches honoring Reed and Manley, and a brief presentation about the new memorial stones, which will be placed at the east and west entrances to the main trail around Tubbs Hill. Members of both men's families will also be present.

The event, which is free and open to the public, will pay tribute to the two individuals most responsible for keeping Tubbs Hill in public hands, as well as for their many other contributions to protecting our natural resources and public recreational opportunities, including access to Coeur d'Alene Lake.

## What's up with the trees dying on Tubbs Hill?

Mark Weadick is a member of the Tubbs Hill Foundation which is a non-profit 501(c) 3 organization whose purpose is to raise money for capital improvements on Tubbs Hill under the direction of the CDA Parks Department.

Most of the people who regularly walk around Tubbs Hill have noticed there are dead and dying Douglas-fir on the north and west sides of the hill. These trees are being killed by Armillaria root rot. You may have also noted these trees are dying in groups.

So, why is this happening on our natural area? In the early 1900's most of the old growth ponderosa pine were logged off the hill leaving a limited seed source for natural ponderosa pine regeneration. If the tree species were in a natural condition, there would be something over 50% ponderosa pine in the stands on the north and west sides of the hill today, and the brush understory would be much less developed. Currently, ponderosa pines are probably not more than 20% of the species composition on these aspects.

The exclusion of fire for the last 100 years has allowed a tall dense brush understory to develop under the Douglas-fir. Ponderosa pine is a sun loving tree and needs mineral soil and sunlight for natural reproduction to become established. This tall brush has created shade and ground cover conditions that prohibit the reseeding of ponderosa pine.


What's this Armillaria? This is a naturally occurring fungus in the soil that primarily attacks and kills Douglas-fir roots, leading to tree mortality. It grows in pockets feeding on dead root tissue, and spreads from tree to tree via root contacts. This spread causes ever increasing areas of Douglas-fir mortality. This is what you are seeing on the hill today.

What's going to happen? If nothing is done, including the exclusion of fir then the Douglas-fir will continue to die and the brush cover will continue to spread into the openings in the canopy left by the dead trees.

What's being done? The management of Tubbs Hill as a natural area is being guided by the Tubbs Hill Management Plan. Within the plan are recommended Management Actions for Vegetation, Roads and Trails, Fire Prevention and Public Services.

In the area of Vegetation Management, the chronic Douglas-fir tree morality is the highest priority. As recommended in the plan, ponderosa pine, western larch and white pine are or are being planted in openings as opportunities arise. These species are very resistant to Armillaria root rot.

# Fire Road Extension & Accessible Trail

Coeur d'Alene Fire Department has developed a management action plan to connect the fire road on the west side of Tubbs Hill to the water service road on the east side of the hill. The approximately 1,100-foot connection provides access to the interior of the hill, increases the margin of safety for emergency personnel and supports management activities related to improving and protecting the natural resources on Tubbs Hill such as fuel reduction, selective vegetative management and exotic plant and weed control.



#### **Tree Planting**

Student and adult volunteers rolled up their sleeves in April to plant 400 tree seedlings on Tubbs Hill. Urban forestry coordinator Katie Kosanke said the project was a great success thanks to the city's Urban Forestry Committee, Community Canopy volunteers, the Tubbs Hill Foundation as well as students from Coeur d'Alene High School's biology class. A combination of larch and ponderosa pine tree seedlings were planted in areas where brush has been removed for fuel reduction purposes. The new trees will provide canopy and shade which will help reduce the density of the shrubs (ladder fuels) naturally, making Tubbs Hill a safer place for recreation.
